PEER-REVIEW POLICY

All manuscripts are initially pre-evaluated by the Editorial Committee to be accepted for publication. Then, at least two reviewers, researchers or academics, assess the manuscripts. The peer review process is double anonymized. Finally, the manuscripts are sanctioned by the Editor-in-Chief or another academic editor authorized by the Editor-in-Chief. CMS accepts, in general terms, the stated guidelines by the International Committee of Medical Journal Editors, www.icmje.org. The manuscripts should be prepared according to the Requirements of Uniforms for Submission of Manuscripts to Biomedical Journals.

INFORMED CONSENT POLICY

Reports, including any data obtained from human participants, must contain a statement on the methods section of the manuscript indicating approval by the institutional research and ethics review board or an equivalent board (including the number and the date of approval).

CONFLICT OF INTEREST, HUMAN AND ANIMAL RIGHTS, AND INFORMED CONSENT POLICY

Submitted manuscripts should not be under review in any other journal. All submissions must disclose all relationships that could present a potential conflict of interest. If there are no conflicts of interest, the authors should state that there are none. The Editors will determine whether any of the relations constitutes a conflict of interest that may have biased the material presented in the paper.

Human procedures must conform with the Ethical Standards of the Declaration of Helsinki of 1975 and the amendments to the agreement (issued by the Ministry of Health) and the Scientific Committee and Ethics institution where the investigation was performed. Each paper should indicate that informed written consent was obtained from each patient to include their information in this publication. The reasons should be provided in the paper if consent was not obtained.

Animal experiments conform to the National Research Council's rules and the institution where it was performed.

Any other situation that may interest must be notified in writing to publishers.
